

**SPECIAL LICENCE**

(off-site)

*Sections 22 and 64, Sale and Supply of Alcohol Act 2012*

**PURSUANT** to the Sale and Supply of Alcohol Act 2012, Rockfall Wines Limited is authorised to sell and supply alcohol from the stall situated at 20G Anzac Avenue, Dunedin, and known as "Dunedin Railway Station Carpark", to any person attending the **Otago Farmers Market** for consumption off the premises and to supply complimentary samples of alcohol on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

**CONDITIONS**

This licence is subject to the following conditions:

(a) Alcohol may be sold under the licence only on the following days and during the following hours:

**Saturday mornings:**

**12 December 2020 to 11 December 2021 (inclusive)**

**8.00 am to 12.30 pm each day**

**and**

**Wednesday 23 December 2020**

**6.30 am to 11.00 am**

**Wednesday 30 December 2020**

**8.00 am to 11.00 am**

(b) Alcohol may be sold or supplied to the following types of people: any person who has attained the age of 18 years.

(c) The licensee must take the following steps to ensure that the provisions of this Act relating to the sale or supply of alcohol to prohibited persons are observed:

Verify age of people appearing under 25 years of age. No sales to intoxicated people.

(d) The licensee must take the following steps to ensure that the provisions of this Act relating to the management of premises are observed:

Certified manager to be present.

**DURATION**

This licence is in force only on the days and during the hours stated above.

**DECISION OF DUNEDIN DISTRICT LICENSING COMMITTEE**

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

**DECISION**

This is an application by Rockfall Wines Limited for an off-site special licence for their stall situated at 20G Anzac Avenue, Dunedin, and known as the "Dunedin railway Station Carpark".

The applicant has requested a special licence so they can market and sell their product at the Otago Farmers Market. They wish to have a presence every Saturday morning from 12 December 2020 to 11 December 2021 (inclusive) and be open from 8.00 am to 12.30 pm each of the days. They would also like to trade on Wednesday 23 December 2020 between 6.30 am and 11.00 am and Wednesday 30 December 2020 between 8.00 am and 11.00 am.

The reporting agencies (Police, Medical Officer of Health and Licensing Inspector) have not raised any matters of concern. There are no extra conditions that need to be added to this licence.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act and we grant the special licence. A copy of the special licence setting out the conditions to which it is subject is attached to this decision.
